Behaviour Management Systems Training (BMST): BMST is a course developed to ensure a respectful learning environment at school. It provides training and support systems for enhancing desirable behaviour and for understanding, preventing, and coping with undesirable behaviour. It emphasizes prevention of disruptive behaviour through awareness of factors affecting behaviour, recognition of early warning signs, and the use of calming / de-escalation techniques, but also teaches personal safety techniques for the rare instances when they are required.
