# a) Board Report

i) Superintendent's Update

Ms. Weller shared updates on the following:

- PPM 128 The Provincial Code of Conduct and School Boards Code of Conduct revision to include a restriction on the use of personal mobile devices during instructional time. PPM 128 highlights the permitted use of personal mobile devices under specific circumstances.
- PPM 163 Service Animals
   All school boards in Ontario are required to develop, implement, and maintain a policy on student use of service animals in schools by January 2020.
- Ontario Autism Program updates regarding the Autism Advisory Panel, extension of existing behavior plans, childhood waitlists and allocations to applicable families.

# ii) Coordinator's Update

September 30<sup>th</sup> Professional Activity Day:

On the Professional Activity Day, Principals began by sharing a PowerPoint from the Leadership Day to walk through various activities with their school teams.

First, they experienced a collaborative STEM challenge where school teams were to build a standing sphere out of Pringle chips. This was based on a Read Aloud entitled, *Iggy Peck the Architect*. School teams reviewed the BIPSA, Strategic Outcomes as well as the Boards' Priorities. Principals reviewed their school data results for EQAO.

Next, teachers participated in the completion of a Grade 6 Reading Task and an open response question. Through this experience, teachers were able to build a common understanding of what identifiers are required in a student response to score a code 30 or 40. They also discussed that the Grade 3 test is a Primary test and the Grade 6 is a Junior test. Every teacher plays a critical role in building the knowledge and skills required to be consolidated by students for each of these tests. Teachers compared student exemplars in the c=scoring guide for that question. Teachers examined Grade 6 multiple choice questions. They built a common understanding of the different types of questions that are on EQAO and how they correlate to the achievement chart; Thinking, Application and Knowledge and Understanding. Then, as school teams staff spent time developing new goals for this year's School Improvement Plans based on various sources of data in Literacy and Math.
