b) Parent Guide

Morning Session:

Applied Behaviour Analysis (ABA)Training

Applied behavior analysis is a science in which interventions are taken from existing research and applied to improve behavior in socially significant ways. ABA is a way to approach behavior that will maximize positive outcomes. ABA requires constructing intervention strategies that define the antecedents and consequences that will result in the increase of positive skills and the decrease of problem behaviors. Decisions regarding the effectiveness of the intervention are based on data collected. Based on the data analysis, interventionist may choose to continue with the intervention or change the intervention to produce positive outcomes for the individual.

This training session will address the following questions: What is ABA? What are the basic principles and methods of ABA? How can antecedents be used to impact behavior? Who can benefit from ABA? What are some of the strategies used in ABA?

Meditation for Students

Meditation is a practice that can be considered many things, including: a skill, a reflection, a prayer. We are increasingly understanding the need and importance of bringing intentional moments of calmness, stillness, and quiet into our daily lives. Join us to learn the benefits of meditation, engage in a variety of meditative experiences and how you can provide similar opportunities for our children.

Afternoon Sessions:

BMST Recertification

Behaviour Management Systems Training (BMST): BMST is a course developed to ensure a respectful learning environment at school. It provides training and support systems for enhancing desirable behaviour and for understanding, preventing, and coping with undesirable behaviour. It

emphasizes prevention of disruptive behaviour through awareness of factors affecting behaviour, recognition of early warning signs, and the use of calming / de-escalation techniques, but also teaches personal safety techniques for the rare instances when they are required.

Lexia Software Training

This research proven, technology based approach provides a blended learning program that accelerates the development of fundamental literacy skills.
