- Ms. Weller shared special education data with the committee, which included:
 - Total Enrolment & Special Education Enrolment (Elementary & Secondary),
 - Not Formally & Formally Identified (Elementary & Secondary), Special Education Overview – Who We Service (Elementary & Secondary), Exceptionality Breakdown (Elementary & Secondary),
- ii. Ms. Weller shared EQAO results have been deferred due to the current health crisis.
- iii. Ms. Weller updated SEAC regarding the SIP application process. NPSC recently received communication from the Ministry of Education indicating the 2020-2021 SIP process has changed. 2019-2020 claims do not need resubmission. New student (2020-2021) SIPS are eligible to be submitted however the process will be temporarily revised. NPSC will be provided with the same base allocation that was received last year for the SIP claim process.
- iv. November 16 2020 is the next date to transition switch to/from virtual learning to in person learning. There has been a trend towards an increase in requests to return to in person learning.
- v. November 20, 2020 is a professional development day for staff.
