12.1 Director's Report and Information Requested in EL-10

a. NPSC Director's Annual Report 2023

As a follow-up to the December 19, 2023 meeting, a copy of the published *2023 Director's Annual Report* was distributed to Board members. P. Mann expressed appreciation to the Senior Team and Communications Team for their contributions to this year's Director's Annual Report highlighting the many achievements of our NPSC students and staff, reflecting great progress on the ENDs.

b. NPSC Student Demographic Data Highlights and Update

An update regarding the NPSC student demographic data project was provided. Ontario school boards are required to gather and report identitybased data to address systemic barriers and discrimination. This demographic data will be used to further enhance evidence-based programming so that the learning needs of all students are equitably served.

In May & June 2023, our survey was shared with parents/guardians for elementary students while secondary students had time in class to complete the survey. Results and information gleaned from the survey was shared with the Board.

iii. International Day for the Elimination of Racial Discrimination

Nominated students from St. Hubert, Our Lady of Sorrows, and St. Joseph-Scollard Hall schools will be highlighted as "Students Who Make A Difference" at the virtual *Recognition of Nominees Day*, live on the North Bay & District Multicultural Center YouTube Channel on Wednesday, March 21, as part of the annual community event to commemorate the *International Day for the Elimination of Racial Discrimination*.

Students have also been invited to participate in a book reflection activity and an Anti-Racism Digital Poster Contest, as part of the community event.

d. NPSC Grade 7/8 Hockey Canada Skills Academy Hockey Elective

In it's second year at SJSH, enrolment in the Hockey Canada Skills Academy program doubled for 2023-2024. The Board was informed that NPSC will be proceeding with a Grade 7 and 8 pilot winter elective program with the HCSA. Any barriers to student participation (fees, access to hockey equipment) will be addressed so that all students can take part in this program. Additional information will be shared at the conclusion of this pilot program to inform our next steps for the 2024-2025 school year.
